

These rules shall govern any contest / promotions conducted by NEUHOFF COMMUNICATIONS AND/OR KMVT.COM and are meant to be in addition to the written contest / promotions specific rules.

1. All contest / promotions on KMVT.COM are designed with fairness in mind and purchase is not necessary.
2. If contest / promotions requires written entry, entries should be mailed to KMVT, 1100 BLUE LAKES BLVD. NORTH TWIN FALLS, IDAHO 83301. Entry must contain your name, address, age and phone number.
3. Contest / promotions participants must be 18 or older to enter and/or win. In some contests the age will be different. The specific age mentioned in the contest will supersede the 18 years of age. In the event the prize is won by a minor the prize delivery must be agreed to in writing by the guardian and the guardian will agree to pay all applicable taxes associated with the prize.
4. Prizes are non-transferable and can not be exchanged.
5. KMVT shall not be responsible for prizes not delivered by any participating sponsor.

All entrants and winners agree that KMVT may broadcast or publish their name, city of residence, photo, videotape, film or any other likeness, including their voice, recorded or live, for any reason deemed necessary, without compensation, and further agrees to hold KMVT blameless and without liability for such publication, broadcast or use. This includes minor children associated with the contest or prize giveaway.

All entrants and winners agree that KMVT, NEUHOFF, and it's affiliates shall have no liability and shall be held blameless for any injury, misfortune or damage to either persons or property insured by entering, participating in, winning or losing any contest / promotions by use or non-use of any prize awarded.
8. Unless otherwise stated, KMVT limits all winners to one per household, per contest / promotion.
9. Winner has thirty (30) calendar days to claim their prize at the KMVT STUDIOS. After 30 days the prize will be forfeited.
